# CONSTRUCTION UPDATES



## MOLLY CROSSING

**Molly Crossing**, a 90-unit senior affordable community in Middleburg, Florida, will be open to residents this summer. Community amenities will include a fitness center, living room with computers, activity room with kitchen, movie room, outdoor gardens and a dog park.



## NATHAN RIDGE APARTMENTS

**Nathan Ridge**, a 192-unit affordable family community, is also located in Middleburg, Florida. The community consists of eight buildings with a clubhouse, swimming pool, fitness center, playground and dog park. The clubhouse and first two buildings will open in August with full community completion expected in November.



## AMBAR TRAIL

**Ambar Trail**, a 210-unit affordable family community located in Homestead, Florida, is scheduled to open to residents this summer. The community includes two buildings with a swimming pool, fitness center, resident lounge with billiard table, game room and a covered terrace overlooking the pool. Construction began on a third building, providing an additional 132 units, early this year and is expected to be complete by the end of the year.



## THE AMBAR

**The Ambar**, a 105-unit affordable senior community located in Miami, is scheduled to open at the end of this year. Construction is topped out, framing is in process with windows expected to go in this summer. Community amenities will include a clubroom, game room and fitness center.



Vestcor recently celebrated the grand opening of Kelsey Cove, a 108-unit affordable family community in Brandon, Florida. This garden-style community consists of 4 buildings comprised of one, two- and three-bedroom units. Community amenities include a clubhouse, swimming pool, fitness center, playground and dog park.



## GROUNDBREAKINGS




### ANDREW LANDING

Vestcor has broken ground on our third community in Hillsborough County, Andrew Landing, located in Riverview, Florida on the Alafia River. This 108-unit affordable family community is a 5-story concrete block and hollow core building consisting of studio, one, two- and three-bedroom units. Construction is expected to be complete in the summer of 2024.

### EMERY COVE APARTMENTS

Vestcor recently broke ground on Emery Cove, a 96-unit affordable family community in Tallahassee, Florida. This community will be similar to Kelsey Cove with 4 buildings, a clubhouse, fitness center, playground, an outdoor pavilion with grills and a dog park. Construction is expected to be complete in early 2024.



**Lofts at San Marco East** is Vestcor's 6th Lofts community in Jacksonville! Construction began early this year on the 172-unit affordable housing community located off Philips Highway and St. Augustine Road. The four-story building will be comprised of studios, one, two-and three-bedroom units with balconies. Amenities include a resident lounge with billiards and shuffleboard tables, an internet café, fitness room, playground and dog park.

## Lofts at Cathedral


Vestcor began construction this spring on our 7th Lofts community, **Lofts at Cathedral**, located in the Cathedral District of Downtown Jacksonville. The community will include a renovation of the existing historic YWCA Building, which will include 28 units, in addition to a new building with 92 units on the same block. Community amenities will include a fitness center, internet café, resident lounge, and a community garden. This mixed income community is expected to be complete in the summer of 2024.
